### **Open Discussion**

Daniel Guy mentioned a resident is interested in installing solar panels and asked whether the Governors Village website or Governors Living magazine would be appropriate for the person to share a general interest article on the subject. Since the website is for official community news, the group agreed approaching the magazine would be the better choice. This topic raised the issue of how to inform and remind residents about ARB requests and other Governors Village policies. Terry includes "Summary Rules & Regulations" in the welcome packet for new residents. This document and other occasional short website articles could be used to highlight such information.
